So many oddities – raising so many questions -but who will answer them?

- 1 You've probably noticed in the same way I have – and particularly over the last three years – there exists in the world some right, real oddities. They're things that hit us as not making sense. Our reaction though isn't intelligent.

I mean that in a kindly sense, since most of us – if not all – are just too busy to ask the questions we all have in our heads – so we DON'T get to voice them. It's all too easy to accept that someone more informed must know the rational answer – but do they? And can we trust them anyway? If our leaders had a wrong agenda they're following, would we know it – would we care?



- 2 Well, why wouldn't we care? But we would, wouldn't we! We would care – as I firmly believe – because the oddities I'm referring to are all the big things in life that are affecting us – in a big way – in how we live our lives. Not least, because nearly ALL of them have a monetary effect on us – and that is reason enough for anyone counting their pennies.
- 3 So, let's take it that we do care AND we have questions we wish to voice. So, how do we voice those questions exactly?

Well, there was a time when others were voicing those questions for us. They were called journalists and they printed their questions in the popular press. That press in more recent times has come to be known as the Mainstream Media **MSM** of course. Those same journalists would put politicians on the spot – often in front of cameras – to answer the questions some of us had in our heads. It was a reasonable system and was even

entertaining in its own way. I'm thinking back several decades now in all honesty.

It was the time when the BBC really seemed to be on their game. They had journalists like **Robin Day** and **Jeremy Paxman**, to name but two – quizzing politicians who would almost visibly shake in front of their probing inquisitor.

As an example, Jeremy Paxman can be seen doing some grilling, in his inimitable style, albeit a little softened at the edges – of someone with more questions than answers. His interview with **Russell Brand** starts with Jeremy being critical of Russell for not voting in parliamentary elections. How positively unreasonable is that you might be thinking – not to vote? Actually, Russell does have a point. I mean – if there's nothing in the baker's shop any of us want to buy – we leave without buying – don't we? If we all did that with elections, what might happen – do you think? To keep voting for these people says we are happy with these people. And who is – really?

- 4 The thing is, today the likes of **Day** and **Paxman** have long since gone and the MSM has been thoroughly captured. See the Media heading below for a stocktake on where we have come to.

So today, we do not have journalists asking questions for us. Neither do we have politicians asking questions for us – which is even more concerning in its way. Oh, there is one – or maybe two – who are prepared to stand up and stick their necks out. In doing that – one MP recently stuck his neck out too far and too often. He got it sliced by his party. **Andrew Bridgen** – the most outspoken MP in the UK parliament today – was ejected from the Tory party for asking too many difficult questions and sharing some most uncomfortable sounding quotes – which were truth bombs in reality. He is the frontrunner in his field by a clear mile. He shows himself to have the intelligence, integrity and – above all – understanding and full awareness that he holds the position he does for and on behalf of ALL the people. That is the People in his constituency and the wider population of Britain. This is indeed a thoroughly rare thing among today's politicians.

Speaking of silencing, there's another story which is being replicated in different countries. The UK is following right behind – as you will already know if you are getting your news from the currently unsilenced oasis for real news on the internet. CONNECT calls this *ALTERNATIVE* to the **MSM** The People's Media **TPM**.

And that Ladies and Gentlemen, is the fundamental problem of this age. There is no one in place to hold politicians – and any puppet masters attached to them – to account. And because politicians know this, there is nothing to prevent politicians doing anything they choose. And they are. People and their questions are being silenced – as you will have seen above.

- 5 This article is not though about what we might do about this state of affairs – as a voting and non-voting public. And in my view, the answer does not reside in compiling and submitting petitions – so genteel an act as that is. It does not mean taking to the streets with pitchforks either – so unsavoury. Although, I do confess that the latter might have a positive visual effect in drawing attention to the problem. The French are very good at this stuff – although I could not condone damage to property or persons.

In my view, these two forms of actions – one paper-based and the other street-based – only reinforce the idea that there are those who are in Control of US all – and the People ARE those who are controlled.

The truth is – once we realise it – the exact opposite of that notion.

We have to remember that it is the politicians who work for the People.

Politicians are in place to do the People's bidding – not the other way around.

As I said earlier, **Andrew Bridgen** understands this concept very well indeed.

3. deserve being explained and all questions answered in detail.

- 6 Now the truth is, the **A-Z p1** list below, could be much longer. The full list is long and is getting longer with the passing of every week. But what I've done in the interest of brevity, is to script a few explanatory notes about each story mentioned and provide a link or two to particular pieces of information. There are many more stories and more oddities under the same and similar subject headings. I will return another time to expand the list for those interested to see them – again in summary form - in the next version **A-Z p2**.

Please note, that I have not personally verified the accuracy of the information provided. What I can say, however, is that the information does not stand alone. In each example there are several, if not many articles, containing corroborating information which provide a level of verification to the information provided. My window for deeper questioning stays open.

What I would impress upon all readers to do, is to delve into the subjects of particular interest to them and verify what they can as a result.

The bottom line with each of the stories mentioned is this.

The questions raised about the different subjects are of sufficient seriousness that they deserve to be looked at and questioned in detail. Maybe some will prove ultimately to be totally inaccurate - and maybe not. Frankly, I doubt they will prove to be inaccurate, but I leave that door of possibility open, as one always should. What is clear in my own view, is that each story warrants a detailed review, with the right level of questioning asked and all questions answered to the full satisfaction of all concerned.

How such a review might come about – facilitating the questions being asked and answered - is a topic for another day.

So, with that said, I invite you to pick a subject from the list of six below. You might begin your search for corroborating information with a visit to a records depository: [The History Book](#) – **THB**.

6A ENERGY – HIDDEN TRUTHS

I thought to start with this subject as it's one which so few of us know about or understand. This perhaps is partly due to certain facts – and if not facts, certain ideas – that have been covered up or hidden.

We're now told – by the WEF and pretty much every state around the world – that we have to wean ourselves off carbon-based fuels. The reasons for this have been shouted loudly – but never clearly. But it's interesting how in-depth discussion on the subject is not allowed. I say this because, top-flight scientists, who have challenging views about climate change, get silenced. In an intelligent society there would be a fully open and transparent debate. And those debates on the subject would involve the best heads around the entire world. That hasn't happened as far as many can tell and is unlikely to happen under the current system. What does that tell us?

But with all that said, there's a fascinating story about power generation here. The thing is – most people will have no knowledge of it. Hmm. Why could that be – we might wonder?

6D COVID CURES – SUPPRESSED

There is much that has been written about the Covid pandemic and there is much still to be written about it. It seemed to many that from the *get-go* there were a number of oddities about the official narrative – that is the narrative that was laid down from the beginning. That official narrative seemed strangely similar to – if not uniform with – those narratives from other international sources. There is no doubt that there are benefits to be derived from experts working together across borders and doing so quickly. That is what all of us were led to believe had happened and – for a while – it sounded convincing.

But there were many commentators – doctors and scientists – that were not convinced. Among those doctors was a S.African born doctor based in the UK. Her name is **Dr Tess Lawrie** and her story began under this topic as a result of listening to another frontline doctor – **Dr Pierre Kory** – giving testimony to the US government about his findings. Those findings related to the treatments he was using to cure patients of symptoms allied to Covid19.

Dr Kory's findings were replicated and confirmed by thousands of similar frontline doctors around the world, all of whom achieved success with their patients as a result of using a combination of drugs and vitamins. At the centre of the treatments used was a drug called **Ivermectin**.

6E SOCIAL MEDIA – CENSORSHIP

It's widely accepted and understood, the first casualty in wartime is truth. Each opposing side kicks in with propaganda which is intended to win the hearts and minds of the home nation. Are there any adults left on the planet who are not aware of this fact? Probably not – but perhaps a few.

So, taking this principle and applying it to the war against the pandemic – starting as it did in 2020 - do we all believe that propaganda COULD HAVE been at play here also? I am of course accepting of the fact that the enemy is not another nation here – as it would be in the normal use of the word. The thing is, there was clearly an enemy at play - according to the government - and that enemy was identified to us all as being *misinformation*. And that *misinformation* was being put out on platforms not considered to be part of the MSM. The MSM has been the delivery system for most governmental communications on the subject and any other sources of information – labelled instantly as *misinformation*, for your information – were censored.

So, the enemy in the case of the pandemic was the opposing narrative which was at odds with the official narrative – the government's. Governments around the world were on to the tails of that enemy almost from the *off*, which instantly set some people's alarm bells ringing. It was another one of those oddities.

With something as serious as the pandemic – and something so apparently visible in its effects - one might think there was no room for a different narrative. Unlike the *elephant in the room* concept, the effects and strategies brought into play would be totally clear to everyone – thus no argument and NO different opposing narrative necessary. The thing was, however, there was an opposing narrative and there WAS an elephant in the room. It was the government which seemed NOT to recognise it. That elephant however wasn't the same one the government told us about every evening.

Listening to the government we were told that the hospital beds were full of C19 patients, as were the pop-up Nightingale Hospitals dotted around the UK's major cities. I spoke to a senior doctor at a Bristol hospital and specifically about the Nightingale Hospital set up on a university campus north of the city. The doctor said the pop-up hospital was empty and it stayed that way. His own hospital in the centre of Bristol was quiet and for two reasons. Few if any C19 patients - and other patients were turned away.

The following two videos were first posted on social media platforms. They were taken down by those same platforms – almost certainly under instruction from their controllers.

The woman who posted the video, about Gloucester Hospital, was subsequently arrested by police in her home. That presumably was to make an example of her. Only the official narrative is permitted to get out. Worrying - I would call that - as I suspect you might think also.

The opposing narrative, of the type I'm pointing to above, could have been rebuffed easily by the government – in principle. This might have been done by showing how things actually were in other hospitals – wheeling out medical staff and patients to confirm what the government were telling us all. That didn't happen of course. And neither did the government respond to the questions asked of it – to explain what was actually going on in the hospitals in the south-west, Gloucester and Bristol.

So, if the above two videos are an indication of the blanking of information by social media platforms, we would have to wonder – and ask – how far does this blanking go? From my own perspective I can say this. It is extensive! And that gets nowhere near the truth of it. To see something sensitive about C19 on YouTube is practically unheard of today – it's shut down. The story above - **Dr John Campbell** and **Andrew Bridgen MP** - is a classic example.

6F MEDIA – AND THE ROLE IT PLAYS IN MESSAGING

There was a time when people had huge respect for journalists and the organisations they worked for. Perhaps in prime place among them was old auntie – otherwise known as the Beeb, or more formerly the BBC. They were considered top notch and untouchable as far as the British public were concerned – and maybe a good slice of the world population too. How things have changed.

Now I know there will be people reading this and thinking - what am I talking about? If any of us only drink one brand of wine or one brand of beer, it's likely we will not notice the taste changing gradually over the decades – if in fact it does. If we flip from one brand to another, we stand more chance of noticing any changes – plus we get to compare one brand against another.

And comparing the BBC against a different platform has shown up some glaring differences over time. More recently that's included what the BBC hasn't been talking about which so many serious commentators on other platforms have been talking about. It's sad – but true.

Now, the number of mainstream media **MSM** platforms around the world has been shrinking. This is no truer than in the USA. In the USA there used to be a myriad of news platforms – almost uncountable in fact – but now they have been amalgamated into an incredible small number. Many of the brandings though have survived but the truth is they are all owned by a senselessly small number of media giants.

The documentary I'm going to share below makes this point very clearly. In this first video, there's a shocking revelation and it's made by a German media editor about the role he has played - over many years - in lying to the people. **Udo Ulfkotte** was a highly regarded journalist until he decided to come clean in what was an extraordinary video confession. It was not long after he made that confession - and the publication of his book on the same subject - that he was found dead.

No one is saying the two events are connected, but - the window of possibility has been left open. He will not have been the first to have met his fate in such a way – upsetting certain elements of the -whatever you may wish to call them.
