Jo Cox – Was She Or Wasn't She?

And that – ladies and gentlemen – is the question for the jury!

- 1 This is one of those curious things that tend to get Conspiracy Theorists all excited - and frankly - I can understand why. The Jo Cox story is fascinating enough but adding in another dimension could make it even more so!

From out of nowhere a Joe Cox charity was started in her memory with a reported fund of £2m raised from people moved by her most untimely demise. I say untimely, but that is where the story begins. The mainstream media reported that Jo Cox – a newly elected MP for Batley and Spen - was killed in the street by a crazed, lone murderer living in the same constituency.



- 2 By all accounts, Jo Cox was a truly lovely person. She loved people and she loved life. She loved the connection between people and was against all forms of hostility. These characteristics and passions she applied to her political life when she became a serving Labour MP - as a result of winning a seat in parliament in the **2015** general election.

- 3 All good so far. But sadly, from relative obscurity, Jo Cox was the chosen victim of an event which took place outside a library in Birstall where she was about to attend her regular surgery with constituents. The media reported that a loner of the town – and without any previous history of violence to anyone or anything – took it upon himself to murder the young mother of two children – with a knife and a gun.

- 4 The grief which covered the nation that tragic day – on **16jun16** and for some time after – was palpable. How could anyone become motivated to do such an evil thing to such a kind, caring and loving person? Indeed, how *could* anyone? How could such a kind and caring person – albeit fairly quiet and private – be motivated to do such a thing?

And that last question – about a man named as Tommy Mair – is an extraordinary important and key question to be answered.

This story is not in the least simplistic, since there are so many peculiarities in the official narrative. Those peculiarities have been laid out in some detail by one private investigator, in particular, who has made a convincing study of the official story. As a result of the investigation, there are clearly so many glaring unanswered questions which have been laid bare.

- 5 I have written about the theory of Conspiracy Theorists before – and recently. However – I make no apology for taking this opportunity to restate what I've said before – and I do so again here. I feel it is incredibly important for people to understand what is meant by the term – how it originally came to be part of the world's lexicon – and why the theories of the Theorists come to exist in the first place.

The term – Conspiracy Theory – was originated in the 1960's by the CIA and is now used ad nauseam to discredit anyone who challenges the official storyline – that being the government's storyline in the main. The term is powerful beyond measure and sows the seed of doubt in anyone's mind when connected with one of those challenges.

Conspiracy Theories are like plants – they grow and thrive in soil which suits them. Take away that soil and they wither and die. The soil – or shall we say circumstance – in which Conspiracy Theories grow and thrive is described here:

1. Too much conflicting information
2. Inconsistencies in the official narrative
3. Too many oddities and anomalies in that same narrative
4. A total lack of transparency – and refusal to offer up transparency
5. The avoidance of questions or – more often – ignoring them altogether

What can develop from these theories – pursued scientifically with professionalism – is an ultimate Conspiracy FACT. FACT is what is left when the official narrative has been exposed as a lie.

Someone looking for the truth will piece together the facts that are known. Where the gaps exist in the exercise, that someone puts in place a stand-in thought or idea. It's a substitute stand-in fact, if you like, which stands to be replaced – or confirmed – later. So, a theory arises and is subject to later modification or collapse due to a different or better theory – OR better still, arrival at THE TRUTH.

- 6 By my mentioning the subject of conspiracy theories, you will have gained the distinct impression that people must sense – and they do so very strongly – that such a theory is associated with the story of lovely Jo Cox.

Unbelievable one might think – but immensely interesting for anyone who places themselves in the room - which I do - labelled:

1. Governments have a proven track record of lying to the public
2. Governments have a track record of staging False Flag Events
3. Truth is the only common goal for good people with integrity

Jo Cox was featured in that article and in summary it said this.

On close analysis of the official narrative – coupled with the video evidence and testimony by experts and journalists – that narrative begins to unravel. Again, like in all these situations, where these oddities and anomalies exist – and answers to basic questions do not - due to them being ignored by official sources - the conditions exist where Conspiracy Theories grow and thrive.

In this story it appears that the named murderer – a resident of the town – was convicted of the crime and sent to prison for life. The problem is that there is so much wrong with the official narrative. Extraordinarily, it has not actually been proved to the public that Jo Cox was murdered.

Yes – as odd as that sounds!

Of course the authorities are happy with that narrative - but others are not. The reason for mentioning all this, and - in part – the reason for writing this article about Jo Cox, is that the circumstances and conditions needed to give rise to alternative counter narratives – alternative theories - exist here.

That said, there is another dimension which MAY or MAY NOT be relevant. I will touch on that dimension towards the end.

Referring to the oddities, the anomalies and all the unanswered questions pertaining and connected to this story, there is what we have come to describe as a Snagging List. And in brief summary, the Snagging List comprises the following problems and unanswered questions.

1. Why were there no photographs of Joe Cox's body made available?
Not even the jury at Tommy Mair's trial were allowed to see them
2. Why wasn't Jo Cox's body moved to the local hospital on the day?
This would have been standard and expected protocol
3. Why was Jo Cox's body moved to London for Post-mortem?
This was wholly unnecessary and irregular
4. Why was the PM carried out by the government's chosen pathologist?
It was the same pathologist who conducted the PM on Dr David Kelly
5. What turns a quiet loving man into a street killer?
All locally acquired evidence suggests that Tommy Mair was innocent

6. Why do experts say, the killer caught on CCTV, is NOT Tommy Mair?
The killer and Tommy Mair are assessed as 2 different men
7. Why was Tommy Mair's arrest conducted in the fashion it was?
A police expert says the arrest was wrong – and contrary to all training
8. Why do the clothes worn by Tommy Mair and the killer differ?
There are key differences in all items of clothes worn
9. Why couldn't Tommy Mair be properly identified in court?
According to record, the accused only said one word – “Yes”
10. Why were Tommy Mair's family and friends excluded from the trial?
This is totally abnormal and has never been explained
11. Why is Tommy Mair not allowed visitors in prison?
Again, this is totally abnormal and cannot be justified
12. Why does the funeral of Jo Cox raise the questions it does?
It is not normal for close family to appear so pleased and happy
13. Why does Jo Cox's husband speak of a new life and a new beginning?
He made these comments in the few days before her reported death

The above list of 13 questions is by no means complete – since they only represent some of the key questions which are still left hanging and unaddressed by the government and its agencies.

I would not be writing on this subject had I not been pointed to an in-depth documentary video – a video which flags all the inconsistencies, oddities and anomalies surrounding Jo Cox and her reported demise.

This video, titled: [Exit From Brexit - The Jo Cox Departure](#)

The video is a 4part documentary which identifies the person convicted of the murder. It also identifies the gaps and holes in the testimony provided by the police and gives clear suggestion that the murder – if that actually happened – was carried out by another person.

The question left hanging - among all the others - relates to the possible motive for staging the event. The documentary points to that motive and it relates to something which the founder of the WEF – Klaus Schwab - spoke about on camera. He suggested that Brexit needed a sympathy vote to turn it towards the *Remain* option - and something like this murder could cause that sympathy vote to happen. Maybe it did, as the Brexit referendum a week later - on **23jun16** - proved a very close-run thing.

When people understand the theory – and suggested intent – behind the occurrences of False Flag Events, this later disclosure causes us to imagine something truly sinister.

Since there might exist a fat question mark over whether or not Jo Cox is dead, could her death – staged or otherwise – have been related to Brexit? Jo Cox was a declared and passionate Remainer and campaigned for the UK to remain in the EU. Could her reported death in the last few days before the Brexit vote have been intended to draw a sympathy vote to the Remain

argument? It sounds like a mad idea of course.

The thing is.

If one believes.:

- in False Flag Events and why they happen
- in Klaus Schwab's belief, that the death could influence the Brexit vote

then maybe this event was staged for that very purpose.

Could it be that Jo Cox is really dead?

Could it be that she is living a new life in a new beginning somewhere else?

One thing is for sure.

The government and its agencies have been less than accommodating when it's come to answering basic questions about the events on the day and after. What should that - alone - be telling people?

- 7 OK – I mentioned earlier that there was perhaps another dimension to consider – with respect to this unsettling story involving Jo Cox.

Directly after her reported death, monies became available through donations to a Jo Cox fund. It would perhaps be interesting to look more closely at the fund created and the reasoning behind it. The questions which arise for some people is:

- Why create a fund in the first place?
- And how did it come to receive such a high level of funding?

The underlying question being - and stemming from this apparent False Flag Event – was there another motive behind its creation?

That said, British people are enormously generous in giving support to others who suffer in some way – and particularly in highly publicised stories.

Accordingly, perhaps there really is *nothing to see here!*

That fund was morphed into what became the [Jo Cox Foundation](#) which is alive and well today. The objectives of the foundation – according to the charity's website – is to further the passions and aims of Jo Cox – the living person. All this and more sounds just wonderful and few people could take issue with anything I have found declared on the charity website.

The charity is perhaps one to cast an eye over from time to time though. The reason for expressing this suggestion, is that it was the founding body for another organisation inaugurated in 2020 – in the midst of the pandemic. That is [Connection Coalition](#).

Again, the organisation - founded in **2020** - appears to have laudable intentions and ambitions. The point to just keep in the back of one's mind however – based on the unanswered questions above and so many others not listed – is that anything arising from the name Jo Cox might be worth looking more closely at. With a Conspiracy Theorist's hat on - one might ask – was perhaps the instigation of the Jo Cox Foundation instigated for another purpose?

Probably not – I'd say – but it's wise to keep an open mind and worth remembering this.

There are two *givens* in the world.

Death and Taxes!

And both need to be proved – and both need to be justified.

The thing is.

There is so much in the way of cast iron evidence which indicates there is so much wrong with the whole pandemic story - put to us all by the government with unbelievable force and conviction – that anything which may have been created with the help of government - connected with the pandemic - deserves everyone's closer analysis.

It is a true shame that such an analysis is required as it appears to be. But in this era of lies entrenched in the official narrative, all stones need turning over, as a mark of good and safe practice.
