Care System Collapse

1 The story of the pandemic is set to take everyone to new depths of despair. PM Boris Johnson - on his visit to Washington for talks with President Biden this week - has told reporters that there will be NO EXCEPTIONS!

2 He was referring to the government's plans to mandate, that all workers in care homes will require a job if they are going to continue working as carers. In brief - his message is "No Job - No Job". We say, "How dare he!" "How callous!"

3 We have all been expecting the government to make some moves on this subject and it now appears that Johnson's plans are set. According to the article posted by [Richie Allen](#) today, Johnson not only declares there will be no exceptions to this decree - but that the ruling will be here to stay.

4 With so many people refusing to take the job - for one reason or another - the care system is set to lose thousands of care workers across the UK. One estimate is that 40,000 care workers will be forced out of their jobs purely to satisfy the government's highly suspect strategy.

All these people have homes to run of their own as well as families to support. Not only that but, just about all of them love their jobs and passionately care for their charges. We are all grateful for them being there and for what they do for our elderly loved ones.

5 We have to say; what is Johnson and his government thinking of?

From our perspective, the government is totally to blame for their handling of the pandemic. That became even clearer just a few months ago when [Dominic Cummings](#) spoke about Matt Hancock. Cummings said that Hancock assured the cabinet - and the country - that care homes would effectively be ring-fenced with the elderly residents protected.

Instead, Hancock allowed the discharge of thousands of hospital patients with C-19 directly into care homes without adequate resources and steps taken to protect the existing residents. The resulting effect on those residents was devastation.

6 Further, the draconian strategy Johnson and his government are following now, does not make any sense. In reality, nothing he and his government has done has made any sense over the past 21mths and we will return to this point in another article soon.

This particular action of theirs is not required in the least. The dangers of C-19 have now been quantified by doctors and scientists all around the world. Safe and effective treatments – including preventative treatments are all known about.

If the right protocols are adopted and applied, then no one should expect to suffer by this virus, including our elderly ones in care homes.
